In recognition of the investment in time and resources required for our high-quality resellers to provide the level of customer service and product knowledge expected from our customers, Oxygen Lab™ is committed to enforcing policies which allow our resellers to maintain high profit margins through the sale of our products. Oxygen Lab™ has an established Minimum Advertised Price (MAP) Policy that an Authorized Reseller must follow for the advertising and marketing of our products. All Oxygen Lab™ Authorized Resellers must agree to the terms and conditions of the following MAP and Authorized Reseller Policy:

SERVICE AND ADVICE TO CUSTOMERS: The authorized reseller must provide sufficient advice and instructions to customers. In addition, authorized reseller commits to personally attend, or designate store manager(s) and/or retail sales staff to attend an annual online training session.

SALES AND MINIMUM ADVERTISED PRICE (MAP): The authorized reseller is permitted only to sell Oxygen Lab™ skincare products to customers within the US at no less than the suggested retail price, or MAP, that is listed on the published/current Price List. The Price List may be changed from time to time at the sole discretion of Oxygen Lab. Authorized resellers are responsible for remaining current with MAP Policy, products, and pricing. Promotions and discounts on products may be applied if advertised to the resellers database of customers only. Any public advertisement below the MAP will be a violation of the policy. Retailers are not permitted to sell Oxygen Lab™ skincare products via the Web unless they receive the express written consent of the National Sales Manager. Violation of this requirement will result in immediate termination of this sales agreement.

ORDERS: May be placed with an authorized sales rep or directly by calling 818-785-9100.

SHIPPING: Orders are shipped via a national carrier from California, unless otherwise requested.

PRICING: All costs will be invoiced in US dollars according to the Price List. (To request a Price List, please contact a sales representative or email info@oxygenlab.com)

DAMAGED ITEMS AND CLAIMS: Should your items arrive damaged, please immediately contact the call center at 818-785-9100 to file a claim. Upon notifying us, we will give you further instructions on how to return the damaged item(s). Important: Please return all damaged items in the original shipping boxes for our inspection. All claims must be made within 24 hours of receipt of order. Any problem or error with an order should be reported to your sales representative. No exchanges will be made without the permission.

RETURNS: Within the first 90 days, if a consumer is not satisfied with the products for any reason, he/she is eligible for a full refund as part of our 90 Day Money Back Guarantee. Resellers are to provide a full refund to the consumer, and we will replace the product for you on your next order. To request the replacement, call 818-785-9100 or speak with your local sales rep.

SALES TAX: To process your order tax-free, a completed state resale certificate form is required. If you are not able to provide the completed form, you will be taxed according to your state’s tax laws.
